1. Appointed Positions (Voluntary) Policy

- 1.1. The Council of Clubs in accordance with by-law 13 can appoint members to positions that will assist Archery WA (AWA) in promoting the objective of the association. The positions will be known as "Appointed Positions".
- 1.2. The positions as indicated in clause 4.1, will be members of the Council of Clubs in an ex-officio capacity.
- 1.3. Affiliated members can apply for any of the positions listed by completing the appropriate form [300-002.02] and submitting it to the AWA Secretary, 7 days prior to the association's annual general meeting.

2. Appointment

- 2.1. Unless otherwise stated in AWA policy, the filling of appointed positions will be conducted at the first meeting of the Council of Clubs after the annual general meeting.
- 2.2. If more than one nomination is received for any particular position, then the council will conduct a ballot of the Council of Club members at the meeting nominated in clause 2.1
- 2.3. If no nominations are received for a particular position or a vacancy occurs between the Annual general Meetings then the Council of Clubs can call for an Expressions of Interest in undertaking the duties of the position.
 - 2.3.1. The Expression of Interest will be advertised amongst the membership of AWA via a General Notice. The Council will then appoint a member to the position.

3. Special Skill Requirements

- 3.1. Any position that requires a particular skill level, competency or statutory requirement to undertake the functions of the position. The Council of Clubs reserves the right to request evidence to satisfy those requirements before accepting a nomination.
- 3.2. The general duties of each appointed position and the any special skill will be contained within a Job Description Form (JDF) which is available to be downloaded from the AWA website.

4. Responsibility to Report to Council

- 4.1. Any member, who undertakes an appointed position, will be required to report to the Council of Clubs on the activities performed, at such time and frequency as determined by the Council and as detailed in clause 4.3.
- 4.2. The appointed positions are as follows:

 - 4.2.4. WA Shooting Association Delegate (WASA),
 - 4.2.5. WA Sports Federation Delegate (WASF),
 - 4.2.6. WA Olympic Games Delegate,
 - 4.2.7. Commonwealth Games Association Delegate,
 - 4.2.8. Anti-Doping Officer,
 - 4.2.9. Member Protection Officer,
 - 4.2.10. Junior Team Manager,
 - 4.2.11. Senior Team Manager,

- 4.2.12. Tournament Chair,
- 4.2.13. State Coach,
- 4.2.14. Coaching Coordinator,
- 4.2.15. Public Relations Officer,
- 4.2.16. Fund Raiser,
- 4.2.17. Youth Coordinator,
- 4.2.18. Judges Administrator,
- 4.2.19. Selection Committee Chairperson.

4.3. Reporting

4.3.1. All reports to council should be in writing and submitted to the Secretary 14 days before the next scheduled Council of Clubs meeting as required in the table below.
